Included by not limited to this general release are all causes arising of nonfeasance, malfeasance, or negligence of the Augusta Ski & Outing Club, its Officers, Directors, and Trip Leader. Any member or guest of the Augusta Ski & Outing Club, who uses his property or loans to another his property for use on or in land, water or air at any Augusta Ski & Outing Club events or function does so at the member's or guest's own risk and said member or guest waives any and all claims against the Augusta Ski & Outing Club, regardless of who uses and/or causes any damage to said property. I (we) agree to hold harmless the Augusta Ski & Outing Club, and its Officers, Directors, Trip Leaders, and each and every Member for any and all claims and the defense thereof of my (our) guests. **Policy Statement** - The Augusta Ski & Outing Club reserves the right to terminate the membership of any member or refuse renewal thereof for good reasons, only known and decided by the majority of the Board of Directors of the Augusta Ski & Outing Club. In such an event, the sole liability of the Augusta Ski & Outing Club shall be the refund of the membership dues paid during the year.
